The President's Corner

I hope you all have enjoyed a safe and happy summer. It's hard to believe we're heading into fall already!

The CISSC board made some decisions earlier this summer that will affect our specialty shows and agility trials. We voted to join the Associated Specialty Clubs in February 2010. Our 2010 specialty shows will be held on Friday, February 12th and Saturday, February 13th at the Indiana State Fairgrounds. The basis of our decision was two-fold. First, we were unable to reserve the Conference Center building at Hendricks County Fairgrounds due to a conflict in dates with the Hendricks County Master Gardeners. The Master Gardeners have a standing reservation for the first weekend in April. Our show dates are based on the corresponding date table provided by the AKC, so they would fall the first weekend in April in 2010. Second, with fewer members and volunteers, the work involved in setup and tear down at our specialty shows has become very cumbersome. The reality is that we have a small, aging membership. The Associated Specialty offers complete setup and tear down without any member involvement. The conformation and sweepstakes judges we selected for 2010 were able to change their schedules, so they will be judging at our specialty shows in February. The judges are: February 12th - Sweepstakes, Jamie Hubbard; Breed, Joyce Van Kirk. February 13th - Sweepstakes, Lori Wilson; Breed, Dianne Hawes, All-breed Obedience and

Rally will be hosted by the Central Indiana Kennel Club and the Hoosier Kennel Club. Our agility trial dates and logistics have changed as well. Starting this fall, our agility trial will be held November 20-22 at Pawsitive Partners Dog Training Center in Beech Grove. The judge for our fall trial is Scott Chamberlain. Our winter agility trial will be held January 16-17, 2010 at Pawsitive Partners Dog Training Center as well. The judge for our winter trial is Lisa Potts. The board felt that holding a one judge trial is much less labor intensive and still affords CISSC the ability to economically support these events.

As the legislative climate changes, the need to support each other is paramount. A few weeks ago, dogs were seized from a Labrador Retriever hobby breeder in Indiana who had fallen on hard times and was not able to give the dogs the proper care given to them in the past. A neighbor complained to the authorities and the dogs were seized by the local animal shelter. Fortunately, there was no HSUS involvement. However, this is a wakeup call for all of us. When a situation like this arises, hobby breeders need to be willing to ask for help from their fellow dog breeder friends. In this day and age of the animal rights movement, it is critical for hobby breeders to band together and watch out for each other. If there is a need, we should be willing to step in when necessary and stay alert to the needs of our fellow breeders. This breeder lost all of his treasured dogs, including a litter of champion-bred puppies. Simply asking for help could have prevented this unfortunate outcome.

CISSC had a very successful day at the "Meet the Breeds" event in conjunction with the Muncie KC show on August 15th. A big thank you to Kathy Morphew for organizing this event and to "Trinket" for her patience in allowing many strangers to pet her. Also, thank you to the member volunteers who talked to the public about our wonderful breed.

Our next membership meeting is Friday, September 11th. I look forward to seeing all of you there.

OF INTEREST FROM AKC BOARD OF DIRECTORS MEETING AUGUST 10-11

Chapter 1, Section 16, of the *Obedience Regulations* was amended, effective January 1, 2010 to allow a dog or handler ineligible to be entered in an "A" Class to be moved to the "B" Class at the same level.

From AKC's Chairman's Report August 2009

-- AKC Archives' Online Digital Collections Growing –

The AKC Archives continues to distinguish itself as the only national repository dedicated to the sport of the purebred dog and covering 125 years of canine history and tradition. The Archives has turned hard copy historical data into digital collections providing the fancy and the public with access at <u>www.akc.org</u>.

The digital collections currently include the AKC Constitution and By-Laws from 1884-1947; nearly 3,000 pages of meeting minutes from 1884 to 1909; the evolution of Dog Show Rules from 1884 to 1931; and the AKC Art Collection. Artwork can be viewed either as thumbnails or a slide show.

http://www.akc.org/about/depts./archive/digi tal_collections.cfm to view and research the collections. Sharing documents, letters, and photos in this way enables the AKC Archives to provide better service and greater access than ever before.

Each new collection we receive must be processed before it's ready to share. Our newest, the John Ashbey photo collection, comes to us with more than 40 years of win shots and portraits as a result of the ubiquitous dog show photographer's move to a new studio. Other new Parent Club collections currently being processed include those from the Chihuahua Club of America, the Bedlington Club of America and rare books from the Poodle Club of America Foundation.

We encourage Parent Clubs to use the Archives as a permanent home for their collections. Any parent club with an upcoming anniversary show can request free copies of items from their collection if they are planning exhibits that would benefit from items that are currently housed in the Archives.

The Archives also develops its own collections, including the Oral Histories, which were begun with interviews of Bob and Jane Forsyth – dogdom's most famous couple. These interviews along with our photos are slated for digitization on the web later this year.

Besides the digital collections we have other interactive pages, such as the 18 page digitized Historical Timeline for the 125th anniversary. As we celebrate this milestone we welcome your stories and anecdotes about your life with dogs and

In addition to the Archives, the AKC Library continues to remain a valuable resource of more than 18,000 volumes for fanciers seeking historical and rare information about purebred dogs and the sport. While still open to the public, visits are now accommodated by appointment. We have established this new procedure to operate the library in a more efficient way considering the small number of monthly visitors.
