## **DIRECTIONS TO THE SHOW SITE**

PAWSITIVE PARTNERS OBEDIENCE TRAINING CENTER (PPOTC) 575 Main Street; Beech Grove, IN 46107

From I 65 N or S, from I 74 E or W and from I 70 E or W, or any other state highways that have exits for Interstate 465 in Indianapolis, take Interstate 465 to SE side of Indianapolis. Take exit #52 / South Emerson St. to the north to Main Street (approx 1 mile from I-465). Turn left (W) on to Main Street. PPOTC is on the left about 3/10<sup>ths</sup> of a mile.

PLEASE NOTE: There is a great deal of road construction around Indianapolis this summer. This includes I-465 as well as I-65 and I-70 passing through the downtown area.
